- Unlike December 2023, the Authority incurred an invoice for Snow removal for December 2024 of \$680.00 was paid The invoices unpaid for snow removal December 24 and January 2025 amount to \$3,680.12 For the winter, I will be the contact for Losch snow removal.

AGENDA ITEM #6 Parking Areas

- Mahantongo Deck.
 - EV Charging income received for December 2024, Net Income \$203.94.
 - EV charging income for January 2025 not received \$305.05. Utility cost \$133.32 (1,111kWh) Net income \$150.05
 - EV \$5.00 charging without a municipal permit, January (30) sessions, net income from charging \$28.05
 - The (2) parking kiosks income for January, \$71.75, NOTE: The Kiosk manufacturer, a French company, was purchased by the Easy Park Group, owners of Park Mobile.
 - The Authority's efforts are ongoing to control demand at the Deck due electric invoices December13, 2024 thru January 15, 2025 Usage -10% and Demand -17%. We are not prepared to decare victory just yet. The \$1.50@ month increase in permit cost for the Mahantongo Deck in 2025 will help.
 - All regular enforcement and maintenance were performed in January 2025
- Capitol Deck
- o Phase 2. Steel repairs and drainage system replacement

Year 2024: (COMPLETE) Final payment for Mar-Allen of \$45,623.65 was made last week of December 2024.

- Phase 3. Repair of retaining wall, epoxy crack seal and painting the steel. (RESCHEDULED) Year 2025.
- Two bids received for painting and when added to the two delayed items from Mar-Allen's original approved bid, will be \$111,802.63 to complete the final phase of the deck project. Benesch recommends that the Pottsville Parking Authority Award the painting project to the low bidder, Evans Commercial Painting, Inc at \$90,415.00, which includes (mobilization, preparation and painting of steel elements.) BOARD APPROVAL REQUIRED.

MOTION to accept the lowest bid by Evans Commercial Painting bid for Capitol Deck as recommended by Alfred Benesch Engineers, by Dermo / Weres.

MOTION passed.

 All regular enforcement and maintenance were performed in January 2025.

Union Station

- The lot should be sealed and any cracks repaired in the next 12 to 18 months. No communication has been sent to either the City administration or SEDCO to resolve this maintenance issue. DISCUSSION over snow removal costs and upcoming lease agreement renewal.
- All regular maintenance and snow removal performed for January 2025.

Arch Street

 All regular enforcement and maintenance were performed in January 2025.

John Potts Lot

 All regular enforcement and maintenance was performed in January 2025

Pottsville Hotel

• The (2) 15minute parking spaces between the Pottville Hotel, the Center for Community Resources and Dr Akbar's office are a source of ongoing violation problems due in part to vehicles parking for longer than 15 minutes and not engaging 4-way hazard lights. and the collapse of the arch between the two building.

 All regular enforcement of the 50 municipal permit spaces was performed as well as regular maintenance for January 2025.

Alvernia Lot

- The PPA has 35 total permits issued to date; (24) to Progressive Vision and (11) to Municipal Permit holders.
- All regular enforcement and maintenance performed in January 2025.

McGeever Pocket Park

All regular enforcement and maintenance performed January 2025.

o Garfield Lot

- All regular enforcement and maintenance performed in January 2025.
- The Redevelopment Authority of the City has completed removal of the back section of the apartment building and the grading of the space in preparation for parking for the Diner and future residents of the refurbished apartments.

o Residential Permits

■ As of December 1, 2024 (141) new 24/25 permits have been purchased @\$50.00 each until January 2025 and now \$30.00 each from 1/1/2025 thru 6/30/2025 producing an income of \$7000.00 to date.

Municipal Permits

- Temporary Single Day and multiple day permits have increased in 2024. Single day permits are \$5.00 @ day
- Special Pricing Request: Residents living in the 100 block of S. Centre Street and 100 and 200 blocks of Mahantongo Street was approved by PPA Board by unanimous vote, a discount for permits at the Mahantongo Deck \$40.75 @ month plus a \$5.00 administration if paid quarterly.
- Six additional special pricing Mahantongo Deck parking permits have been purchased by those residents effected by the special pricing.

 - 482 tickets issued; through the T2 program.
 - MPS Safety Stick violations January 2025- 24 violations.
 - Total Enforcement Revenue Billed \$9,570.00

- Realized January Income \$4,473.97

 Magisterial income for January 2025 \$1,460.27
- PPA Executive Director has agreed to a 90-day test to determine if the MPS units are viable for the City. This period ended February 1st. A Meeting to be scheduled with MPS to determine if Safety Stick program is viable.
- Currently (1) Vehicles is on the Scofflaw Report. The vehicle owner has been sent notification that if the tickets remain unpaid the vehicle if located will be towed and impounded.

Park Mobile

- 1,096 more parking sessions were recorded in January 2025 compared with December 2024.
- \$3,970 more in net income was received during the (21) days of January 2025 compared to 13 days in December 2024.
- Average parking session based 189 hours during January, decreased from two hours and thirty minutes to two hours longer than both October and November an increase of 15 minutes.

Parking Meters

 25 on-street meters are currently out of service and must be repaired.

- A review of electric bills at the Mahantongo Parking Deck, is ongoing, for the fourth month in a row usage decreased December 13 thru January 15th,2025 usage 10% and demand decreased 17%, 2025 We will continue toward the goal of controlling Demand and Usage compared with prior year energy usage at the Mahantongo Deck.
- The request from M&T Bank Manager to agree to (3) dedicated on street parking spaces in front of the Banks branch in the one hundred block of S. Centre Street for a yearly price; decision to be made by the Board at the February 14, 2025 Board meeting. BOARD Decision Required.

Discussion about 3 spaces.

MOTION to vote to maintain the current policy of "first come, first served", for on-street parking in the Pottsville Business District by Weres / Hoppe. MOTION passed.
