FAO:		

- Permits are sold on a first-come, first-served and space-available basis.
- Parking at Municipal Lots is on a first-come, space-available basis. (No reserved or assigned spaces)
- The Parking Permit is issued for a specific parking lot/garage and is valid per City Ordinance from 8:00 A.M. through 5:00 P.M., Monday through Friday. At other times, the parking lot / garage is open for public use, without having to display a permit.
- The annual rate is set as of January 1st, and is good January through December.
- All permits expire on December 31st of each calendar year.
- Permits are invoiced and paid on a 3-month or 12-month basis (January-December).
 - o Rates do not include a non-refundable Admin Fee of \$5.00 with each billing cycle.
 - o If Payments are not received by the 10th day of the quarter, we will disable your permit.
 - o If your account is not paid by the 10th day of the quarter, a \$15 ticket will be issued each time your vehicle is parked in the Municipal Lot, unless it is on the ParkMobile app.
 - o Patrons are entitled to a prorated, un-used full-month refund in the event of early cancellation.
 - A replacement permit for one that was lost or stolen is \$25.00
- The vehicle permit requires the license plate must be registered with the Pottsville Parking Authority. Plates that are not properly displayed are subject to ticketing.
- All permit holders must pull into parking spaces in the deck or lot, so that the plate is scannable from a car or on foot. What that means to each permit holder is that they MAY NOT BACK INTO a parking space.

Permit Refund Policy

- A pre-paid permit is eligible for a refund for any unused full month, provided the Authority is notified in writing by mail or email.
- There are no refunds on temporary permits.
- There are no cash refunds.
- Refunds are based on a prorated schedule of un-used full months remaining on the contract. Refund amounts are determined on the day the cancellation is received.
- Refunds on permits that were paid for by check or cash will be processed through Pottsville Parking Authority, and a check will be mailed. This process takes approximately two (2) weeks.
